What is a Lead or Coordinator?

A Lead or Coordinator is a *Rank and File* member responsible for workflow and work load but NOT Discipline, hiring and/ or firing of other *Rank and File* members. *Under our contract that is a Management (MPP) responsibility.*

Have you been asked to perform work out side of your job description?

Remember Safety always comes first! Any unsafe work environment PLEASE contact a steward as soon as possible! Otherwise complete the task if you are "able" and contact a Steward to check if it is a GRIEVABLE offense.

You have the *Right to Representation!*

Any possibility of discipline? Ask .. then get a Union Rep!

You have a *Right to your Job!*

Thanks to the Union, you own your Job.

You have a *Right to give a Voice!*

Together, we fight for better work conditions and pay.
